The Planning Commission of Liberty Township, Adams County, met on Tuesday, June 20, at 7:30 p.m. in the Liberty Township Municipal Building, 39 Topper Road, Fairfield, for the regular monthly meeting.

Judie Hogan called the meeting to order at 7:30 p.m.

Presentation:

Adams County Office of Planning and Development Presentation on Adams County Comprehensive Plan Historic Resources

Jenna Smith explained that the Heritage Plan is an update to the county comprehensive plan, which was last updated 2010. They are now updating the preservation plan (Heritage Plan), which hasn't been updated since 1991.

She is attending municipal meetings to capture the public's perception of historic preservation and understand historic resources they would like to learn more about. She has already met with the National Register of Historic Places. They want to capture stories of underrepresented groups and stories outside of the Civil War, which may not have been as well known.

They will create a map and other items for the project website.

The Planning Commission shared ideas on local historic resources to focus on preserving and learning more about, in addition to the Steelman Marker:

- Two old homes on Ranch Trail on west side of Rt. 16. Used to be the post office and general store, when the road was called T-311. Mary Elizabeth Buckham and Wilbur Shank might know more.
- On Friends Creek Rd., there is a pre-Civil War cabin with an addition. Judie can give her contact info.
- On Crum Rd. are one of the oldest homes in the county (1780s), which was perhaps a trading post, and the Abraham Krise Farmhouse, dating to about 1830. Ann Ruppert has info.
- Luther Ridge lives on the Douglas Piper property on Liberty Hall, dating to 1836-65.
- Bob Jackson could share info on the glider port.
- Art Snyder's home on Tract Rd. is historic.
- On Wenschoff Rd., Richard Swiat's home is old. There are also old stone homes on Pumping Station Rd. and Middle Creek Rd.
- Grace Baptist Church on Tract Rd. and St. Mary's Cemetery near Fairfield are old.
- There's an old schoolhouse on Pecher Rd. Agatha Foscato may have info.

Jenna has not yet talked to the Fairfield Historic Society.
